


Edward Wilson

Our Founder, Edward Wilson, was born around 1550 in Cartmel, Lancashire, from where he progressed to Trinity College, Cambridge. From university, Edward Wilson entered the Church, being appointed Deacon of Ely Cathedral in 1576. He subsequently became Vicar of the Parish of Camberwell in 1578, an appointment which was bestowed upon him by Queen Elizabeth I in person.


On 29th September 1615, Edward Wilson obtained letters patent from the Crown to enable him to open a Free Grammar School on seven acres of land in Camberwell, adjacent to the Church of St Giles. The Patent Rolls declared that the school should be for “the better education, institution and instruction of the children and youth of the poor in that parish”.

Edward Wilson's motivation can be explained through his own humble background. Wilson had been a Sizar (subsidised place) at Cambridge University having benefitted from a free grammar school education. Subsequently, Wilson understood the value of a grammar school education in accessing otherwise unattainable opportunities. Wilson's School was and is still guided by this principle today.

At that time, the establishment of a grammar school in England required the assent of the Sovereign. This was obtained after the first school buildings were constructed, and the legend ‘Founded in 1615 by Royal Charter’ is now displayed near the main entrance.

The final codicil of Edward Wilson’s will was completed on Sunday 29th November 1618. In his will, Wilson bequeathed to the Governors of the school the land on which the school was situated, as well as his personal library.

A few days after the completion of his will, Edward Wilson died. He was subsequently laid to rest in the Church of St Giles.

Over four hundred years after his death, Edward Wilson's legacy of founding a free grammar school in South London has retained its purpose and resonance.



Securing Our Future

Since its foundation in 1615, the school has faced many challenges with fortitude and optimism. Edward Wilson would have been proud of the way in which Wilson's continues to thrive. The school is centred around the outstanding pastoral care it provides. Its pastoral system very effectively communicates the core values of respect, acceptance and service. The motto of the school - 'Non Sibi Sed Omnibus' (Not For Oneself But For All) - drives all that we do.

Academically, its performance also ranks it among the most exceptional state schools in the country and in 2021 the Sunday Times announced Wilson's as its 'London State Secondary School of the Decade'.



Wilson's is proud of its rich sporting, cultural and social programme which continues to give pupils a unique opportunity to develop the skills and qualities on which their futures will depend. We believe that an all-round education not only serves individual development but is also increasingly valued within the world of work, where teamwork, imagination and service are central to many of today's most successful enterprises.

The school is thriving, and although we are successful, we are not complacent. Continuous improvement is essential and for this to happen, we need your support.

Despite its continuing success, Wilson's is not a wealthy school. Whilst out-performing independent schools, **Wilson's, as a state school, operates under significant budgetary strictures, running all its services for 25% of the average budget of local fee-paying schools.** If it wasn't for the generosity of parents, the support of the Wilson's Charitable Trust CIO, and the work of the Development Office, Wilson's would not be able to provide the rich experiences that it does.

Further Action

Your will is an excellent way to provide for the people who are important to you, to help causes you support and to acknowledge the influences that have shaped your life. By remembering Wilson's in your will, you can ensure that the school continues to move forward into the future with confidence.

By making a charitable gift in this way, you can also reduce the total tax liability of your estate to your family. All legacies to Wilson's are free from Capital Gains Tax and Inheritance Tax.

Making a legacy pledge to Wilson's is quite straightforward. It can be done either when making a will for the first time or, by adding a codicil to an existing will.

We suggest you contact your solicitor to discuss how that may be done.



What Next?

If you have decided to leave a legacy to Wilson's, here is a quick summary of what you might consider doing next:

- If you have not yet made a will, please consider contacting your solicitor for advice.
- If you have already made a will naming Wilson's as a beneficiary but have not told us about it, please let us know by completing the legacy pledge form which is enclosed on p.11. Please download, print and fill out this form before returning it to us either by scanning and emailing it to development@wilsonsschool.sutton.sch.uk or by posting it to us using the postage details provided on the penultimate page.
- If you have already made your will and just want to make an alteration to it, please complete the codicil form which is enclosed on p.12. Please download, print and fill out this form before returning it to us either by scanning and emailing it to development@wilsonsschool.sutton.sch.uk or by posting it to us using the postage details provided on the penultimate page.
- Although a legacy pledge has no legal status, it is a most encouraging indication to the school of your support. It would also be helpful to us if you were prepared to indicate the value of your gift.
- We would prefer that your bequest is made for the general purposes of the school as this offers us maximum flexibility to support the needs of the pupils; but, if you prefer, you can ask for your bequest to be used for a specific purpose. Please indicate your wishes on the legacy pledge form.



Types Of Bequest

Pecuniary - A pecuniary bequest is a gift of a specific sum of money.

Specific - A specific bequest (or bequest in kind) could be of stocks and shares, land or any other property, or works of art.


Residuary - A residuary bequest is a gift of the residue (or a percentage) of an estate after other bequests have been made.

Reversionary - A reversionary bequest is one which allows named persons to benefit from assets during their lifetimes, after which the assets are transferred to the ultimate beneficiary.

Substitution - Testators can provide for the eventuality that their named dependants do not survive them by making a conditional bequest to other beneficiaries, perhaps including Wilson's.

Deed of Variation - If you become a beneficiary of someone else's will, you may wish to consider transferring the whole or part of that inheritance to Wilson's using a deed of variation. The value thus transferred would be exempt from the Inheritance Tax which would otherwise have been payable out of the estate in respect of that value.

It is of course possible to combine one or more of the above.
